New York Citizens Audit Uncovered:

- Official counts from 2020 disagree, Secretary of State vs Board of Elections, by 272,000 votes

In addition, NY Citizens Audit is calling for the decertification of the 40 Democrat NYS Assembly members who ran unopposed, the 8 Republican NYS Assembly members who ran unopposed, the 8 NYS Democrat Senators who ran unopposed, the 5 Republican NYS Senators who ran unopposed, and the Democrat US Congressman who ran unopposed. These individuals represent another 32% of our Assembly, 21% of our Senate, and 4% of our representation in the US Congress. Disregard by these bodies for the rule of law has broken our trust in the innocence of these circumstances.
