Who are we?

Founded in 2021, New York Citizens Audit is a non-partisan, all-volunteer, 501(c)(3) non-profit corporation dedicated to restoring and maintaining the essential, founding American principle of sovereignty through honest, provable elections in New York and across the nation. Using publicly available voter roll databases obtained directly from state and local boards of elections through the NY Freedom of Information Law (FOIL), NY Citizens Audit conducted audits of the 2020 and 2022 elections.

What did we find?

The results are alarming: New York voter rolls have massive irregularities which appear to violate state and federal law. We uncovered millions of seemingly invalid registrations, hundreds of thousands of votes inexplicably cast by these ineligible registrants, and the undeniable presence of a secret, illegal computer algorithm in the voter rolls—a breach of our national security infrastructure.

5,142,950 Apparent
registration violations*

The voter rolls must be accurate as required by the National Voter Registration Act of 1993.

745,294 Apparent
voting violations*

The votes counted must be from eligible voters as required by the US Constitution.

► Election officials certified provably inaccurate, non-compliant elections in 2020 and 2022.

What are we doing about it?

We contacted the NYS Board of Elections, the Department of Homeland Security, the DOJ Public Integrity Office, the FBI and the Special Investigation Unit of the New York State Police demanding an official investigation into our findings. We have also presented to 89 members of the New York State Assembly and the NYS Legislature Election Law Committees in Albany. *(Please see reverse for a timeline of our efforts.)*

Rather than investigate our findings, officials have either refused to respond or have spread misinformation about NY Citizens Audit. **So, we must now pursue legal recourse.** We are NOT trying to overturn election results. Our clear and concise legal strategy will restore and enforce legally compliant elections which protect the rights of all voting eligible Americans, according to the legal standards outlined in “Federal Prosecution of Election Offenses, Eighth Edition,” a 2017 publication of the DOJ.

▶ A TIMELINE OF OUR WORK

2021

▶ SUMMER:

Founder Marly Hornik initially organized a team to investigate the NYS 2020 election.

▶ FALL:

NY Citizens Audit (NYCA) obtained digital copies of the publicly available New York State (NYSVoter) voter database and County voters rolls for the 2020 election under the Freedom of Information Law (FOIL).

▶ 2021 into 2022:

Analysis of the voter rolls, state and federal laws regarding elections and civil rights, and research validation initiatives confirm massive amounts of invalid data within our voting system, from registration through certification. NYCA leadership initiates public presentations of the team's findings.

2022

▶ SPRING:

Andrew Paquette, Ph.D. and the NYCA research team discover and reverse-engineer mathematical algorithms within NYSVoter.

County volunteers obtain over 5,000 of petition signatures demanding an investigation of the 2020 election.

▶ MAY / JUNE:

Twenty-nine petitions are delivered to the NYS Board of Elections, NYS Attorney General, NYS Secretary of State, NYS Democrat and Republican Party Leadership (May 9 and June 27), as well as 9 County Legislatures, Sheriffs, District Attorneys, and County Party Leadership, representing over 95% of the population of NYS.

NYCA presented evidence to the NY State Police Special Investigations Unit that seems to reflect large scale illegal manipulation of the NYS Voter database. The investigation is passed to the FBI.

▶ JULY 11:

New York Citizens Audit officially becomes a 501(c)(3) non-profit corporation.

▶ AUGUST:

Marly Hornik exposes algorithmic programming in NYSVoter at the True the Vote event with Catherine Engelbrecht and Gregg Phillips. Kim Hermance joins General Flynn at a live Re-Awaken conference to publicly announce the findings and then presents at Mike Lindell's Moment of Truth Summit, leading to a large increase of volunteers.

▶ FALL:

NYCA's "New York's 2020 General Election: A Study in Deficits" report is released.

NYCA County Teams are organized in 40 out of 62 Counties.

2023

▶ JANUARY:

NYCA county team members led by Steve Gillan present 2020 findings to 89 members of the New York State Assembly in Albany.

▶ FEBRUARY to PRESENT:

NYCA County Teams present the Resolution for Audit to villages, towns, and counties across New York State. 244 Resolutions requested and fulfilled in 42 Counties.

Danielle Cassase creates County Teams in NY City.

▶ MAY:

Marly Hornik and Dr. Paquette present "A Technical Briefing: NYSVoter Type 2 Data Breach" to all Election Committee members from each Chamber in Albany.

"The Caesar Cipher and Stacking the Deck in the New York State Voter Rolls," a peer-reviewed research article by Dr. Paquette, is published in the *Journal of Information Warfare*. Cyber-intelligence experts confirm the "steganographic" algorithms (hidden in plain sight) in NYSVoter.

▶ AUGUST:

NYCA releases its 2nd report: "New York's 2022 General Election & the Reign of Error: Apathy, Incompetence, or Malfeasance?".

Marly Hornik presents NYCA 2022 findings at the Election Crime Bureau Summit and announces a national initiative: United Sovereign Americans.

▶ SEPTEMBER:

NYCA submits its data and analyses to the NY Board of Elections, NYS Division of Election Law Enforcement, Dept. of Justice, FBI, DHS, and NYS Police.

NYCA sends letter to Congress asking for an investigation.
